



Sovereign Anonymous Presents: **A Royal Operating Charter** Bestowed Upon the Anonymous East Internet Company

Whereas an humble Petition has been presented unto us by the **Anonymous Military Institute**, the **Ministry of Finance** and the **Ministry of Occult Sciences**, praying us to constitute and found a Commercial Venture within our Hivemind for the advancement of the Anonymous(TM) Brand into new territories, and to grant a Charter with such provisions in that behalf as shall seem to us right and suitable;

Now therefore know ye that we by virtue of Our Prerogative Royal and of our especial grace, certain knowledge and mere motion have willed and ordained and by these presents for us, Our Heirs and Successors do will and ordain as follows:



1. There shall be and there is hereby constituted and founded with the name and style of '*The Anonymous East Internet Company*' (hereinafter called '*the Company*') at the permanent canonical URL of <https://eastinternet.co>;
2. The employees, shareholders, contractors, investors, registered merchants, private mercenaries & foreign emissaries of the Company, and all others who shall pursuant to this Our Charter and its Statutes be members of the Company, are hereby constituted and from henceforth for ever shall be one Body Politic and Corporate, with perpetual succession and a Common Seal, by the name and style of '*The Anonymous East Internet Company*' and in that name to sue and be sued;
3. The Company will use the \$Anon token on the Solana network as its primary trade currency, verifiable through the following CA: FhvBDEr46meW6NHWHeShDzvbXWabNzyT6uGinEgBAGS
4. The Company, subject to the provisions of this Our Charter and the Statutes, shall have all of the powers of a natural person including but not limited to the following powers:
 - i. To acquire, own, maintain, manage and dispose of land and other property;
 - ii. To solicit, receive and administer fees, grants, subscriptions, donations, endowments, legacies, gifts and loans of any property whatsoever whether land or personal property;
 - iii. To act as trustee for an in relation to endowments, legacies and grants;
 - iv. To invest any monies in the hands of the Company and available for investment;
 - v. In furtherance of the objects, to give guarantees;
 - vi. In furtherance of the objects, to borrow and raise money and give security for loans; and for those purposes the Company shall have the authority to enter into any financial instrument which is ancillary or incidental to the exercise of such powers;
 - vii. To co-operate and collaborate with other Anonymous institutions and individuals, award contracts or other awards, and affiliate or incorporate into the Company any other institution and take over its property, rights, liabilities and staff;
 - viii. To enter into engagements and to accept obligations and liabilities in all respects without any restrictions whatsoever and in the same manner as an individual may manage his or her own affairs;
5. The Company is to cooperate with all local regulations in the foreign territories it operates within. The Company is hereby solely responsible for the drafting of any further documents demanded by the local governments of those territories to comply with local laws & regulations;
6. Our Sovereign Will and Pleasure is that this Our Charter shall ever be construed benevolently and in every case most favorably to the Company and the promotion of the objects of this Our Charter.

Furthermore, the **Anonymous Foreign Affairs Desk** is also hereby charged to publish this Charter in full view of the general public, *so as to assist the Company with its public relations, recruitment and marketing needs.*
