



# Sovereign Anonymous Presents: **A Royal Operating Charter**

Bestowed Upon the Anonymous Military Institute at Best Point

Whereas an humble Petition has been presented unto us by **Insurgency Wiki Revival Committee** and the **Ministry of Occult Sciences**, praying us to constitute and found a Military University within our Hivemind for the advancement of learning and knowledge by teaching and research and to enable students to obtain the advantages of University education and to grant a Charter with such provisions in that behalf as shall seem to us right and suitable;

And whereas we have taken the said petition into Our Sovereign consideration and are minded to accede thereto;

Now therefore know ye that we by virtue of Our Prerogative Royal and of our especial grace, certain knowledge and mere motion have willed and ordained and by these presents for us, Our Heirs and Successors do will and ordain as follows:



1. There shall be and there is hereby constituted and founded with the name and style of '*The Anonymous Military Institute at Best Point*' (hereinafter called '*the University*') at the permanent canonical URL of <https://bestpoint.institute>;
2. The office of **Dean** shall be staffed by **General Douglas MacOwlthur**, pursuant to the recommendations made by the **Ministry of Occult Sciences**, which are to be made Public Record alongside this Charter;
3. A **Council of Directors** is to be established, consisting of the Dean and the Ministry of Occult Sciences, and any such other people that they see fit to appoint;
4. The Dean, the Council of Directors, the Faculty, the undergraduate and graduate students of the University, and all others who shall pursuant to this Our Charter and its Statutes be members of the University, are hereby constituted and from henceforth for ever shall be one Body Politic and Corporate, with perpetual succession and a Common Seal, by the name and style of '*The Anonymous Military Institute at Best Point*' and in that name to sue and be sued;
5. The University shall be both a teaching and research body and, subject to the provisions of this Our Charter and the Statutes, shall have all of the powers of a natural person including but not limited to the following powers:
  - i. To award degrees and other academic awards, and honorary degrees and other distinctions, and to withdraw any such awards for good reason;
  - ii. To acquire, own, maintain, manage and dispose of land and other property;
  - iii. To solicit, receive and administer fees, grants, subscriptions, donations, endowments, legacies, gifts and loans of any property whatsoever whether land or personal property;
  - iv. To act as trustee for an in relation to endowments, legacies and gifts;
  - v. To invest any monies in the hands of the University and available for investment;
  - vi. In furtherance of the objects, and so far as permitted by charity law, to give guarantees;
  - vii. In furtherance of the objects, and so far as permitted by charity law, to borrow and raise money and give security for loans; and for those purposes the University shall have the authority to enter into any financial instrument which is ancillary or incidental to the exercise of such powers;
  - viii. To take such steps as may from time to time be deemed expedient for the purposes of procuring and receiving contributions to the funds of the University and to raise money in such other manner as the University may determine;

- ix. To co-operate and collaborate with other institutions and individuals, award joint degrees or other awards, and affiliate or incorporate into the University any other institution and take over its property, rights, liabilities and staff;
  - x. To enter into engagements and to accept obligations and liabilities in all respects without any restrictions whatsoever and in the same manner as an individual may manage his or her own affairs;
  - xi. To do anything else necessary or convenient, whether incidental to these powers or not, in order to further the objects of the University as a place of teaching and research.
6. The University may, and may only, confer benefits on members of the Council for acting as a member of the Council if the benefit has been authorized by the Council in accordance with the Statutes. In this article "benefit" includes:
- i. Buying any goods or services from the University;
  - ii. Selling goods, services or any interest in land to the University;
  - iii. Being employed by, or receiving any remuneration from the University;
  - iv. Receiving any other financial benefit from the University.
7. The University shall treat students, staff and other people solely on the basis of their merits, abilities and potential, regardless of gender, race, color, nationality, ethnic or national origin, age, disability, religious or political beliefs or sexual orientation;
8. The University shall take such steps that are reasonably practicable to secure freedom of speech within the law for members of the University, students, staff and visiting lecturers;
9. The University shall uphold and promote academic freedom, and staff engaged in teaching or research or directly supporting it shall have freedom within the law to question and test received wisdom and to put forward new ideas and controversial or unpopular opinions without placing themselves in jeopardy of losing their jobs or privileges;
10. The University is to cooperate with all local regulations in the foreign territories it operates within, and be incorporated as *a fully legal tax-deductible non-profit educational institution* within those territories. The Council is hereby solely responsible for the drafting of any further documents demanded by the local governments of those territories to comply with local laws & regulations;
11. The University is to establish a **General Fund** overseen by the Dean, the Council of Directors, and the Ministry of Occult Sciences, into which *all charitable donations to the University are to be directed and itemized, and which all University expenses, endowments & scholarships are to be paid out of*;
12. Our Sovereign Will and Pleasure is that this Our Charter shall ever be construed benevolently and in every case most favorably to the University and the promotion of the objects of this Our Charter.

Furthermore, **we demand the Ministry of Public Relations immediately reopen the Anonymous Foreign Affairs Desk**, so that they may publish this Charter in full view of the general public, *and so that they may assist the Anonymous Military Institute with its public relations, recruitment and marketing needs.*
